Astro-Wings membership requires our members to belong to our national association, the Academy of Model Aeronautics (AMA). The AMA provides our members with insurance and a monthly magazine.

The AMA is the world's largest model aviation association, representing a membership of more than 150,000 from every walk of life, income level and age group. The AMA is the official regulating, record keeping and contest ruling body and although official operations commenced in 1936, its heritage can be traced back to 1905. The Astro-Wings hold AMA charter #1167 and most events are sanctioned with the AMA.

Don't let anyone tell you that the radio control hobby is difficult to understand, or that RC models are hard to build. If you've seen a modern RC airplane taxi around on the ground, take off, land, and do aerobatics, you may have assumed that all this took many hours of construction and an electronics education. WRONG! The fellow who is flying that apparently complex RC plane probably has no understanding of electronics and he may have constructed the plane in a very few evenings.

On the other hand, we don't know of any hobby that is as open-ended as RC. It can be as complex as you want to make it. We know of members who have spent thousands of hours creating a totally scale airplane that won the RC Scale World Championships. There are other hobbyists practicing RC flying three hours a day who have raised their flying proficiency to such a point that no full scale pilot would ever begin to match the spectacular and precise maneuvers that these RC planes can accomplish. So, you can make this RC hobby as simple or complex as you want. You can pursue it for a lifetime and still be challenged.

The hobby of building and operating radio models is fantastic! The excitement of piloting your own aircraft is a satisfying experience and it is easy to become addicted. The challenges are significant and the accomplishments are most rewarding.

Club membership is an essential requirement for those involved in model aviation. The benefits of insurance coverage, instructions in developing flying skills and availability of a flying field are the most obvious. Come join us!
